WAIVER AND RELEASE OF LIABILITY

AND ASSUMPTION OF RISK ACKNOWLEDGEMENT

DEFINITIONS:

Facilities – The stables, stalls, campsites, grounds and other facilities and improvements situated on or forming part of the property located at 750 West Deep Creek Road, Bryson City, North Carolina 28713.

Indemnitees - James Clark and his family members, heirs, executors, administrators, successors and assigns.

Indemnitor - The individual signing below and his/her heirs, administrators, executors, and assigns.

The Indemnitor hereby releases, relinquishes, acquits and forever discharges the Indemnitees and each of them from any and all liabilities, claims, causes of action, damages, obligations, suits, demands, costs and expenses of any sort or kind whatsoever or however arising, in law or in equity, whether known or unknown, whether in tort or in contract, which Indemnitor had or now has, or may have had or now may have, or that Indemnitor at any time in the future has or may have, against Indemnitees or any of them as a consequence or arising out of (i) illness, injury and/or death to or of Indemnitor or any horse or other livestock or animal brought to the Facilities by Indemnitor, (ii) damage to or the destruction of vehicles, trailers or other property brought to the Facilities by Indemnitor, and (iii) Indemnitor's use of the Facilities and/or the services provided at the Facilities.

Indemnitor represents to Indemnitees as follows:

- 1. I am 18 years of age or older.
- I am signing this release, waiver of liability, and assumption of risk acknowledgement voluntarily and of my own free will.
- I have no physical or emotional problems, nor any history thereof, which will impair my ability to utilize the Facilities and its services in a safe manner.
- 4. I understand and agree that it is my responsibility to assess the hazards presented by my use of the Facilities and services provided at the Facilities and further agree that I am the ultimate judge as to whether I can use the Facilities and services without risk of harm to myself or animals or property in my possession or under my control.
- I have inspected the Facilities, agree that I will be using the Facilities on an AS-IS, WHERE-IS basis, and understand and EXPRESSLY ASSUME all the dangers incident to using the Facilities and the services provided at the Facilities.
- 6. My use of the Facilities is entirely optional and my own free choice.
